RE: Permission to Copy the State of Wyoming's Driver License Manual

Dear Bill:

The Department of Transportation will grant permission to the National Safety Commission, Inc. to include a reprint of Wyoming's Driver License Manual based on the following criteria.

- 1) They shall not use the Wyoming Department of Transportation (WYDOT) as a reference to raise money for advertising in the Directions 101 that will be distributed in Wyoming or any other state.
- 2) They shall not include advertising in our Wyoming Driver License Manual or in the section where our manual will be located.
- 3) The Wyoming Driver License Manual printed publication is updated every two years. We are granting permission to print the version that is dated 2006. The National Safety Commission, Inc. must request permission from WYDOT when the new publication is printed in 2008.
- 4) WYDOT is held harmless if the National Safety Commission, Inc. makes any errors in printing our Driver License Manual.
- 5) The National Safety Commission, Inc. will not sell or give permission for anyone else to print our manual without the express written consent of WYDOT. All rights are reserved. The Wyoming Driver License Manual or parts of it must not be reproduced in any form without permission in writing from the publisher. The Wyoming Driver License Manual is in the public domain and no copyright over that portion of the Directions 101 or other publication of the National Safety Commission, Inc. shall be claimed or asserted, except as is otherwise permitted for its compilations.

Please have them return the signed original of this letter to me, which shows that they agree to the terms outlined.
